Dear Madam/Sir,

This is to bring in your kind attention regarding the 'illegal construction' being erected beside 23, J.N.B. Lane, Baranagar, Kolkata-700036. The said illegal construction is being constructed on a plot of land situated at 8, Kali Prasanna Nyayratna Lane, Baranagar, Kolkata - 700036.

Please note that the undersigned is a resident/owner of a land scheduled as "1 Cottah 7 chattacks 24 sq. ft., Dag No: 6434, Khatian Nos. 6911, 6963, 6964 Hal 12662, J.L. No. 5, Holding No.165, Moza: Baranagar, P.S.: Baranagar,

Residence : **'anekanta'**, 23/1 Joy Narayan Banerjee Lane, Baranagar, Kolkata 700036

Dist. 24 Parganas (North)" adjacent to the land whereof the said illegal construction is being carried out.

An effortless view of the said 'illegal construction' will Prima facie reveal that the said building is being constructed in violation of Municipal Corporation Act and statutes thereof as such massive construction cannot be legally sanctioned on a land connected with just a 4ft. Road. Further information is received that the said illegal construction will end up in a four-storied (?) apartment. You are further notified that there is visible illegal extension of the floors by cantilever, which is anticipated to be in excess of the existing sanctioned building plan to the best of my knowledge.


Please note that the said illegal construction will affect the rights, interest and peaceful possession of the undersigned, other persons of the vicinity and above all, bio-diversity of the habitat.

Therefore it is humbly submitted that immediate steps to be taken from your end to stop any further illegal construction or any further unauthorized extension/erection and also necessary steps for removal of such illegal construction and communicate the same to the undersigned within 10 days from receipt of this notice.

You are further requested to supply us in my cost, copy of the building plan sanctioned in respect of the plot/premises where the said illegal construction is being constructed.
