



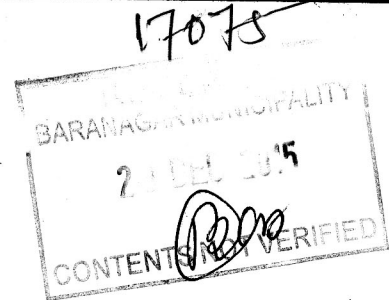

Dear Sir,

I, the undersigned, is a resident of Anekanta, 23/1 Joy Narayan Banerji Lane, Baranagar, Kolkata-700036 and is owner of a land scheduled as "1 Cottah 7 chattacks 24 sq. ft., Dag No: 6434, Khatian Nos. 6911, 6963, 6964 Hal 12662, J.L. No. 5, Holding No.165, Moza: Baranagar, P.S.: Baranagar, Dist. 24 Parganas (North)".

That the undersigned being aggrieved by an 'illegal construction' being erected at 8 Kali Prasanna Nyayratna Lane, Baranagar, Kolkata - 700036 have made a complain to the Chairman Baranagar Municipality vide letter a dated 29th September, 2015. In the said letter specific request was made for "stop any further illegal construction or any further unauthorized extension/erection and also necessary steps for removal of such illegal construction and communicate the same to the undersigned within 10 days from receipt of this

notice" and a copy of the same was also forwarded to the local Councillor and the local Police Authority.

It is pertinent to mention that even after such specific complain was made the alleged illegal construction continues to operate and no signs of regularization/removal of such illegal construction exists.

In the addition to the above the members associated to such illegal construction continues to dominate and is constantly pressuring and threatening the undersigned and family with dire consequences in the event of **raising any further objection against the said illegal construction.**

I hereby request the Public Authority, Baranagar Municipality to answer/clarify to all my queries as raised below:

- a) What are the steps/action taken by the Baranagar Municipal Authority towards the complaint made against the said illegal construction? If any, copy of documents recording such steps/actions be sent to the undersigned.
- b) Whether any stop order issued against the said illegal construction? If yes, what is the date of passing such order? And a copy of the order be sent to the undersigned.
- c) Whether any building plan sanctioned in the said premises? If yes, a copy of the plan sanctioned be sent to the undersigned.

Being a citizen of India, I have full right to seek information/ clarity from the Public Authorities as guided by Section 3 of the Right to Information Act 2005.

All the information as requested above should be furnished within 30 days from the receipt of the said application as prescribed under the said Act.

I am also enclosing herewith Indian Postal Order Rs. 10 Dated 19/12/2015, numbering 11F 772306 as a Relevant Fees under Right to Information Act, 2005. It is to be noted that relevant fees as prescribed by Govt. of India vide section 6(1) of the said act. Please also inform me if any further Relevant Fees under Right to Information Act, 2005 is required by the bank in this connection.

Please treat this matter as "URGENT".
