### Sub: Human rights compromised with regard to Case No. 4642/25/5/2022

Dear Mr. Raveendran,

I am not at all surprised to view your answer to [my complaint on financial abuse](#) as I already anticipated that my plea would not be entertained, though it is closely related to the **United Nations Guiding Principles on Business and Human Rights, viz., the Access to remedy for victims of business-related abuses**. Two of my family members also appealed to your commission (**Diary No. 17826/IN/2022 and Diary No. 17904/IN/2022**), seeking refuge for **infringement of business-related human rights**. However, all of us got the very same "copy-paste" reply from the concerned Section Officers of the NHRC Law Division. All the previous complaints are available [on our website](#). All these prove the severe impotency of the NHRC. Furthermore, I have also understood that all the fundamental human rights, the freedom of the press etc., are utterly compromised in the "party free" Indian democracy, as reported by various international human rights organizations:

Kindly remember the dictum "*International Law is the vanishing point of jurisprudence*". It is also to be noted that the NCLT First order and NCLAT Second order have already revealed the illegitimacy of the RBI-appointed CoC for DHFL.

**Moreover, how did you relate an evident case of financial abuse (a different type of 'capital' punishment) with "property rights and contractual obligations"? Is it not part of your international human rights obligation to uphold these basic rights of your citizens, since there is a different category in the NHRC e-complaint form entitled "*Business and Human Rights*"?**

As the RBI does not deal with property-related issues, but financial issues, therefore, it is wrong to say that it is merely related to "property or contract" alone.

I am forwarding this letter along with the case history of the concerned financial scam to the *Office of the United Nations High Commissioner for Human Rights* (OHCHR). It is a matter of regret that as citizens of India, we are demolishing the image of our own country!

To conclude: I am losing faith in the Indian judiciary.
